LICENSE AGREEMENT

This agreement is based on the Creative Commons Attribution-ShareAlike 4.0 International License Agreement

This license agreement ("License Agreement") has been entered into by, on the one hand:

- Safety Centre Europe BVBA, Noorderlaan 133, 2030 ANTWERPEN, Belgium; and
- Université de Lorraine, cours Léopold 34, 54052 NANCY, France; and
- XVR Simulation BV, Westlandseweg 40, 5E, Verdieping, 2624 AD DELFT, Netherlands; and
- University of Sheffield, Firth Court Western Bank, SHEFFIELD S10 2TN, United Kingdom

, below referred to together as the "Licensors", and, on the other hand

- the Licensee, as defined below.

By exercising the Licensed Rights (defined below), the Licensee accepts and agrees to be bound by the terms and conditions of this License Agreement. The Licensee is granted the Licensed Rights in consideration of the Licensee's acceptance of the terms and conditions in this License Agreement, and the Licensors grant the Licensee such rights in consideration of benefits the Licensors receive from granting the Licensed Rights according to the terms and conditions in this License Agreement.

Section 1 – Definitions.

- a. **Adapted Material** means material subject to Copyright and Similar Rights that is derived from or based upon the Licensed Method and in which the Licensed Method is used, translated, altered, arranged, transformed, or otherwise modified in a manner requiring permission under the Copyright and Similar Rights held by the Licensors.
- b. Adapter's License means the license that the Licensee applies to the Licensee's Copyright and Similar Rights in the Licensee's contributions to Adapted Material in accordance with the terms and conditions of this License Agreement.
- c. **Copyright and Similar Rights** means copyright and/or similar rights closely related to copyright including, without limitation, performance, broadcast, sound recording, and Sui Generis Database Rights, without regard to how the rights are labelled or categorized. For purposes of this License Agreement, the rights specified in Section 2(b)(1)-(2) are not Copyright and Similar Rights.

- d. Effective Technological Measures means those measures that, in the absence of proper authority, may not be circumvented under laws fulfilling obligations under Article 11 of the WIPO Copyright Treaty adopted on December 20, 1996, and/or similar international agreements.
- e. **Exceptions and Limitations** means any exception or limitation to Copyright and Similar Rights that applies to the Licensee's use of the Licensed Method.
- f. License Elements means the license attributes of this License Agreement.
- g. Licensed Method means the Incident Evolution Methodology (IEM) and its six steps, further described in the CascEff deliverable D4.2 available on the CascEff website: www.casceff.eu. It is acknowledged that the research leading to these results has received funding from the European Union Seventh Framework Programme (FP7/2007-2013) under grant agreement n° 607665.
- h. Licensed Rights means the worldwide, royalty-free, non-sub licensable, nonexclusive and irrevocable right to use and exercise the Licensed Method or the Adapted Material (as specified), limited to all Copyright and Similar Rights that the Licensors have / Licensee has authority to license, which is granted according to this License Agreement.
- i. **Licensors** means the entities granting rights under this License Agreement, as stated above.
- j. **Share** means to provide material to the public by any means or process that requires permission under the Licensed Rights, such as reproduction, public display, public performance, distribution, dissemination, communication, or importation, and to make material available to the public including in ways that members of the public may access the material from a place and at a time individually chosen by them.
- k. **Sui Generis Database Rights** means rights other than copyright resulting from Directive 96/9/EC of the European Parliament and of the Council of 11 March 1996 on the legal protection of databases, as amended and/or succeeded, as well as other essentially equivalent rights anywhere in the world.
- 1. **the Licensee** means the individual or entity exercising the Licensed Rights under this License Agreement.

Section 2 – Scope.

- a. License grant.
 - 1. Subject to the terms and conditions of this License Agreement, the Licensors hereby grant the Licensee the Licensed Rights, including the right to:

A. reproduce and Share the Licensed Method, in whole or in part; and

- B. produce, reproduce, and Share Adapted Material.
- 2. <u>Exceptions and Limitations</u>. For the avoidance of doubt, where Exceptions and Limitations apply to the Licensee's use, this License Agreement does not apply, and the Licensee does not need to comply with its terms and conditions.
- 3. <u>Term</u>. The term of this License Agreement is specified in Section 6(a).
- 4. <u>Media and formats; technical modifications allowed</u>. The Licensors authorize the Licensee to exercise the Licensed Rights in all media and formats whether now known or hereafter created, and to make technical modifications necessary to do so. The Licensors waive and/or agrees not to assert any right or authority to forbid the Licensee from making technical modifications necessary to exercise the Licensed Rights, including technical modifications necessary to circumvent Effective Technological Measures. For purposes of this License Agreement, simply making modifications authorized by this Section 2(a)(4) never produces Adapted Material.

5. Downstream recipients.

- A. <u>Offer from the Licensors Licensed Method</u>. Every recipient of the Licensed Method automatically receives an offer from the Licensors to exercise the Licensed Rights under the terms and conditions of this License Agreement.
- B. <u>Additional offer from the Licensors Adapted Material</u>. Every recipient of Adapted Material from the Licensee automatically receives an offer from the Licensors to exercise the Licensed Rights in the Adapted Material under the conditions of the Adapter's License the Licensee applies.
- C. <u>No downstream restrictions</u>. the Licensee may not offer or impose any additional or different terms or conditions on, or apply any Effective Technological Measures to, the Licensed Method if doing so restricts exercise of the Licensed Rights by any recipient of the Licensed Method.
- 6. <u>No endorsement</u>. Nothing in this License Agreement constitutes or may be construed as permission to assert or imply that the Licensee is, or that the Licensee's use of the Licensed Method is, connected with, or sponsored, endorsed, or granted official status by, the Licensors or others designated to receive attribution as provided in Section 3(a)(1)(A)(i).

b. Other rights.

1. Moral rights, such as the right of integrity, are not licensed under this License Agreement, nor are publicity, privacy, and/or other similar personality rights; however, to the extent possible, the Licensors waive and/or agrees not to assert

any such rights held by the Licensors to the limited extent necessary to allow the Licensee to exercise the Licensed Rights, but not otherwise.

- 2. Patent and trademark rights are not licensed under this License Agreement.
- 3. To the extent possible, the Licensors waive any right to collect royalties from the Licensee for the exercise of the Licensed Rights, whether directly or through a collecting society under any voluntary or waivable statutory or compulsory licensing scheme. In all other cases the Licensors expressly reserve any right to collect such royalties.

Section 3 – License Conditions.

the Licensee's exercise of the Licensed Rights is expressly made subject to the following conditions.

a. Attribution.

- 1. If the Licensee Shares the Licensed Method (including in modified form), the Licensee must:
 - A. retain the following if it is supplied by the Licensors with the Licensed Method:
 - i. identification of the creator(s) of the Licensed Method and any others designated to receive attribution, in any reasonable manner requested by the Licensors (including by pseudonym if designated);
 - ii. a copyright notice;
 - iii. a notice that refers to this License Agreement;
 - iv. a notice that refers to the disclaimer of warranties;
 - v. a URI or hyperlink to the Licensed Method to the extent reasonably practicable;
 - B. indicate if the Licensee has modified the Licensed Method and retain an indication of any previous modifications; and
 - C. indicate the Licensed Method is licensed under this License Agreement, and include the text of, or the URI or hyperlink to, this License Agreement.
- 2. the Licensee may satisfy the conditions in Section 3(a)(1) in any reasonable manner based on the medium, means, and context in which the Licensee Shares the Licensed Method. For example, it may be reasonable to satisfy the

conditions by providing a URI or hyperlink to a resource that includes the required information.

3. If requested by the Licensors, the Licensee must remove any of the information required by Section 3(a)(1)(A) to the extent reasonably practicable.

b. ShareAlike.

In addition to the conditions in Section 3(a), if the Licensee Shares Adapted Material produced by the Licensee, the following conditions also apply.

- 1. The Adapter's License the Licensee applies must be a license consisting of the License Elements.
- 2. the Licensee must include the text of, or the URI or hyperlink to, the Adapter's License the Licensee applies. The Licensee may satisfy this condition in any reasonable manner based on the medium, means, and context in which the Licensee Share Adapted Material.
- the Licensee may not offer or impose any additional or different terms or conditions on, or apply any Effective Technological Measures to, Adapted Material that restrict exercise of the rights granted under the Adapter's License applied by the Licensee.

Section 4 – Sui Generis Database Rights.

Where the Licensed Rights include Sui Generis Database Rights that apply to the Licensee's use of the Licensed Method:

- a. for the avoidance of doubt, Section 2(a)(1) grants the Licensee the right to extract, reuse, reproduce, and Share all or a substantial portion of the contents of the database;
- b. if the Licensee includes all or a substantial portion of the database contents in a database in which the Licensee has Sui Generis Database Rights, then the database in which the Licensee has Sui Generis Database Rights (but not its individual contents) is Adapted Material, including for purposes of Section 3(b); and
- c. the Licensee must comply with the conditions in Section 3(a) if the Licensee Shares all or a substantial portion of the contents of the database.

For the avoidance of doubt, this Section 4 supplements and does not replace the Licensee's obligations under this License Agreement where the Licensed Rights include other Copyright and Similar Rights.

Section 5 – Disclaimer of Warranties and Limitation of Liability.

a. Unless otherwise separately undertaken by the Licensors, to the extent possible, the Licensors offer the Licensed Method as-is and as-available, and makes no representations or warranties of any kind concerning the Licensed Method, whether

express, implied, statutory, or other. This includes, without limitation, warranties of title, merchantability, fitness for a particular purpose, non-infringement, absence of latent or other defects, accuracy, or the presence or absence of errors, whether or not known or discoverable. Where disclaimers of warranties are not allowed in full or in part, this disclaimer may not apply to the Licensee.

- b. To the extent possible, in no event will the Licensors be liable to the Licensee on any legal theory (including, without limitation, negligence) or otherwise for any direct, special, indirect, incidental, consequential, punitive, exemplary, or other losses, costs, expenses, or damages arising out of this License Agreement or use of the Licensed Method, even if the Licensors have been advised of the possibility of such losses, costs, expenses, or damages. Where a limitation of liability is not allowed in full or in part, this limitation may not apply to the Licensee.
- c. The disclaimer of warranties and limitation of liability provided above shall be interpreted in a manner that, to the extent possible, most closely approximates an absolute disclaimer and waiver of all liability.

Section 6 – Term and Termination.

- a. This License Agreement applies for the term of the Copyright and Similar Rights licensed here. However, if the Licensee fails to comply with this License Agreement, then the Licensee's rights under this License Agreement terminate automatically.
- b. Where the Licensee's right to use the Licensed Method has terminated under Section 6(a), it reinstates:
 - 1. automatically as of the date the violation is cured, provided it is cured within 30 days of the Licensee's discovery of the violation; or
 - 2. upon express reinstatement by the Licensors.

For the avoidance of doubt, this Section 6(b) does not affect any right the Licensors may have to seek remedies for the Licensee's violations of this License Agreement.

- c. For the avoidance of doubt, the Licensors may also offer the Licensed Method under separate terms or conditions or stop distributing the Licensed Method at any time; however, doing so will not terminate this License Agreement.
- d. Sections 1, 5, 6, 7, and 8 survive termination of this License Agreement.

Section 7 – Other Terms and Conditions.

a. The Licensors shall not be bound by any additional or different terms or conditions communicated by the Licensee unless expressly agreed.

b. Any arrangements, understandings, or agreements regarding the Licensed Method not stated herein are separate from and independent of the terms and conditions of this License Agreement.

Section 8 – Interpretation.

- a. For the avoidance of doubt, this License Agreement does not, and shall not be interpreted to, reduce, limit, restrict, or impose conditions on any use of the Licensed Method that could lawfully be made without permission under this License Agreement.
- b. To the extent possible, if any provision of this License Agreement is deemed unenforceable, it shall be automatically reformed to the minimum extent necessary to make it enforceable. If the provision cannot be reformed, it shall be severed from this License Agreement without affecting the enforceability of the remaining terms and conditions.
- c. No term or condition of this License Agreement will be waived and no failure to comply consented to unless expressly agreed to by the Licensors.
- d. Nothing in this License Agreement constitutes or may be interpreted as a limitation upon, or waiver of, any privileges and immunities that apply to the Licensors or the Licensee, including from the legal processes of any jurisdiction or authority.
